To be eligible for the scholarship the applicant must:

- **Be a member of Journey Federal Credit Union since the beginning of the current calendar year and in good standing.**
- **Be enrolled as a High School Senior at the time of application.**
- **Must be accepted/enrolled in an accredited institution and/or working towards their first undergraduate degree.**
- **Use scholarship funds for tuition or textbooks.**
- **Include a High School transcript.**
- **Include at least 2 non-relative letters of recommendation.**

Applicants must submit the entire application packet to one of the three Journey Federal Credit Union locations by **April 30, 2023** or mail completed application to:

The selection process will be based upon subjective criteria including essays, academic performance, community involvement, curricular & extracurricular activities, and personal goals. Scholarship winners will be contacted directly and, when applicable, announced at their schools' awards ceremony.

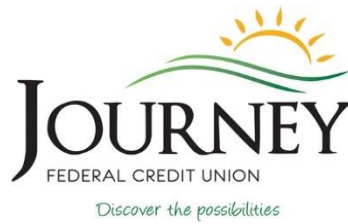
