CHECK YOUR CREDIT

Federal law allows you to get a free copy of your credit report every 12 months from each credit reporting company: Equifax, Experian, and TransUnion. If you're not sure what your credit report is, why you should care about it, or how to get it, we're here to help.

What is a credit report?

A credit report is a summary of your personal credit history and includes identifying information, such as your date of birth and address, and information about your credit history — like how you pay your bills or if you filed for bankruptcy – that has been reported by your financial institutions as well as nationwide chain stores and credit card companies. This information is collected and updated by three nationwide credit bureaus (Equifax, Experian, and TransUnion).

The information in your credit report can affect your chance to get a job, rent or buy an apartment or home, purchase insurance, qualify for loans, and more.

How to order your free annual credit reports.

FINANCIAL GOALS for the New Year

Get ready to start fresh on your financial goals with these tips for the new year.

TRACK IT – By tracking your spending daily, you can ensure your financial goals remain on track. Tracking options range from simple pen and paper to Excel spreadsheets and financial apps. There's something for everyone—find what works best for you and then remain diligent in tracking daily.

PAY YOURSELF – To successfully build your savings each month, we recommend two things: 1) Before paying bills and spending money, transfer 10% of your income to your savings account (and then don't touch it!); 2) Schedule automatic transfers from your regular checking to your savings after every payday, so you don't even have to think about it.

DON'T SPEND IT – Too many spontaneous purchases often cause the need to borrow from saving. By dedicating one week per month as a no-spend week, you can be more intentional about saving while becoming more cognizant of your spending habits throughout the rest of the month.

MAX IT OUT – One of the easiest, smartest, and most effective ways to maximize your retirement savings is to maximize any employer 401k matches. If you've already done that, an IRA from JFCU help you continue expanding your retirement savings.

File on time. The IRS tax filing deadline is Monday, April 15, 2024.

Finish your 2023 IRA contributions. You have until Monday, April 15, 2024, to make 2023 contributions.

Watch the mail for your credit union tax forms. We will soon be mailing out Forms 1099 and 1098, which report dividend and

interest information. If you receive these forms, be sure

to save them for your tax preparation.

Request Direct Deposit. Complete the Direct Deposit line on your tax form to receive your tax refund in as little as 10 days. Be sure to include our routing number (272484836) and your credit union account number.

Give TurboTax a go. Follow the link on our website, and TurboTax will guide you through the entire tax-filing process.

Ask about a Tax Loan. If you find yourself owing taxes, stop by the Credit Union to learn more about our special low-rate Tax Loan.
